"É Verdelho Verdelho ou Verdelho Gouveio?" a resposta pode muito bem ser "é Verdelho Verdejo". Confuso? É para estar. Muitos são os que acreditam ter provado Verdelho, mas poucos são os que provaram. A semelhança botânica entre as castas Gouveio e Verdelho, vale à primeira ser mal catalogada durante anos como Verdelho, dando azo a uma enorme confusão. Para piorar, a espanhola Verdejo, próxima de nome, é também confundida com Verdelho. Estas três castas são distintas entre elas. Este Verdelho é "o Original", o das ilhas, o da frescura, o da salinidade, o da mineralidade e do perfume único que fez o Verdelho ser... O Verdelho!

"Is it Verdelho Verdelho or Verdelho Gouveio?", the answer might well be "it is Verdelho Verdejo". Confused? You should be. Many people believe that they have tasted Verdelho, but few have. Gouveio (aka Godello) was for several years wrongly identified as Verdelho generating this huge confusion. Verdelho, Gouveio and Verdejo are 3 distinct grape varieties, often confused. This is the original Verdelho, the one grown on the islands, the one with the mineral taste, and salts that teases the palate, and the one with the unique perfume that made Verdelho be... Verdelho!
