This rich, flannel-soft red pairs beautifully with braised and roasted meats, such as lamb shanks, rib roast, and osso buco. It is produced from vines planted in 1965 within the Rioja wine region (Zone 3) at 700m (2,296') elevation, growing in red silica soil. Average temp. during the April-October growing season is 16.3° C (61.5° F); annual rainfall is 465mm (18.3"). It is aged 24 months in 80% French and 20% American oak barrels.
