O conde de Silves era apaixonado pelo mar e pelas vinhas do Algarve. Em finais do século XIX plantou as suas primeiras cepas no Morgado do Quintão. Hoje, quase 200 anos depois, celebramos essa legado e a herança de um Algarve genuíno neste Palhete Algarvio. Inspirado nos vinhos daqueles tempos, misturando as uvas brancas e tintas mais tradicionais da região (Crato Branco 70% e Negra Mole 30%). Criámos um vinho único, ideal para acompanhar os famosos pratos do peixe e marisco algarvio, entre amigos e família. Enóloga: Joana Maçanita.

The count of Silves fell in love with the sea and the vineyards of the Algarve. At the end of the 19th century he planted his first vines at Morgado do Quintão. Today, almost 200 years later, we celebrate his legacy and the "real Algarve" with this Palhete Algarvio. Inspired by how wines used to be made in the Algarve, mixing white and red grapes from local grape varieties (Crato Branco 70% and Negra Mole 30%), we created a wine that is unique and faithfully honours the winemaking tradition of this region.
