

VINHO BRANCO - WHITE WINE

Nesta Ilha, há mais de 500 anos que se plantam vinhas nas fendas da rocha vulcânica, a escassos metros do mar, onde se ouve o "cantar do caranguejo". Após o devastador ataque do oídio e da filoxera no séc. XIX, a mão teimosa do Homem manteve uma pequena bolsa de vinhas que resistiu à extinção. Este "Vinha Centenária" é uma dessas vinhas com mais de 100 anos que resistiu e ficou guardiã das castas autóctones dos Açores e testemunha do encepamento tradicional.

In this Island, for more than 500 years, vines are planted in the cracks of the lava bed, a few meters from the ocean, where you can hear the "crabs singing". After phyloxera and oidium plague devastated the vineyards in the XIX century, a small pocket of vineyards resisted to extinction. This "Vinha Centenária" is from one of those vineyards with more than 100 years that guardian of the Azorean exclusive grape varieties and witness of the traditional vineyards composition.
