No sopé da Serra d'Ossa, está este Chão dos Eremitas, local onde os Eremitas da Ordem de São Paulo, Os Paulistas, escolheram plantar as suas vinhas. Dois riachos trazem as águas das chuvas da Serra mantendo o chão fresco no tórrido calor alentejano. Estas vinhas eram de tal importância que uma Bula Papal de 1397 isenta Os Paulistas de tributos nas vinhas e reforça a sua importância. Plantada em 1970, a nossa vinha de Vale do Cepo tem castas que em tempos dominaram a paisagem vitícola da região, mas quase desapareceram.
