The "Crosta Calcária" (limestone crust) is a remarkable zone characterized by the accumulation of Quaternary marine fossiliferous limestone in the northern region of the island, reaching depths of up to 30 meters. This wine originates from old vineyards that thrive in these soils, where Caracol and Listrao grape varieties coexist. The result is 933 bottles of a wine with a truly unique personality, boasting the influence of this unique terroir.

Porto Santo island emerged in the Atlantic Ocean 14 million year ago, being geologically one of the oldest islands of the Portuguese archipelagus. It's also the first island to be discovered by the portuguese sailors, led by Zarco, in 1418. The ancients say that it was from here that the rippest grapes were harvested for the wine that made famous these islands. Today there are less than 14 hectares left, farmed by a group of resiants. In the neighbour island the people of Porto Santo are known as the "Prophets", an ancient nickname that has never made more sense when you see these old vineyards planted by the sea, close to the ground, protected from the ocean and the wind by rock walls (crochet walls) or by ingenious cane structures.

Behind this wine, Nuno Faria, madeiran and restaurateur, and António Maçanita, winemaker and explorer of extreme terroirs, Friends for more than 15 years and have joined forces to celebrate and explore the potential of these enchanted islands.
