The grape Tinta Negra is part of the ancient composition of grapes of this island, being still today the base for the wines that make this island famous. Rare, it is also found in small quantities in two other regions, always close to the ocean where it is known as *Molar* or *Saborinho*, but it should not be confused with the varietal Negra Mole from the south of Portugal. It seems that its role in the past was to taint white wine in order to give it a golden hue very much in fashion at the time. As a red grape, it has always been seen as an inferior grape for red wine. Is it so? That's what we want to find out.

Behind this wine, Nuno Faria, Madeiran and *restaurateur*, and António Maçanita, winemaker and explorer of extreme terroirs, friends for more than 15 years and have joined forces to celebrate and explore the potential of these enchanted islands.
