This technique involved separating the lighter, fresher "vinho flor" and extracting the golden and intense "vinho da corda" from the final pressings, popular at the time. Our Vinho da Corda originates from sunny Porto Santo vineyards, showcasing the island's potential for rich, authentic, and naturally oxidative wines. Less than 14 hectares remain, cultivated by resilient locals known as the "Prophets." Nuno Faria, a Madeiran restaurateur, and António Maçanita, an explorer of extreme terroirs, unite their expertise to explore and celebrate the hidden treasures of these enchanting islands in a bottle.
