Wine Description: Calchetas is the flagship wine of the renown winery Bodegas Viña Magaña. It is Deep red with complex aromas of ripe fruit and cacao. On the palate intense, expansive, very rich in fruit. Its texture is elegant and polished. Full body with a long persistent fresh finish.

Location: Zone 3, in the town of Barillas, Navarra. The winery Bodegas Viña Magaña owned by Juan Magaña was founded in 1970 owing 247 acres of vineyard land.

Soils: Topsoil is made of gravel, clay and limestone, and its subsoil is mostly composed of gravel. The surface of these vineyards is very rich in minerals and its subsoil provides good levels of water draining capacity, enabling the surface minerals to reach the deep roots on the subsoil, which provide nourishment to its root system.

Climate: Continental Atlantic; moderate warm days and cool nights, with 8.3 inches of rainfall between May and October. The rainfall levels of his vineyard are uncommon for this climatic zone, making richer and fuller wines than neighboring producers.

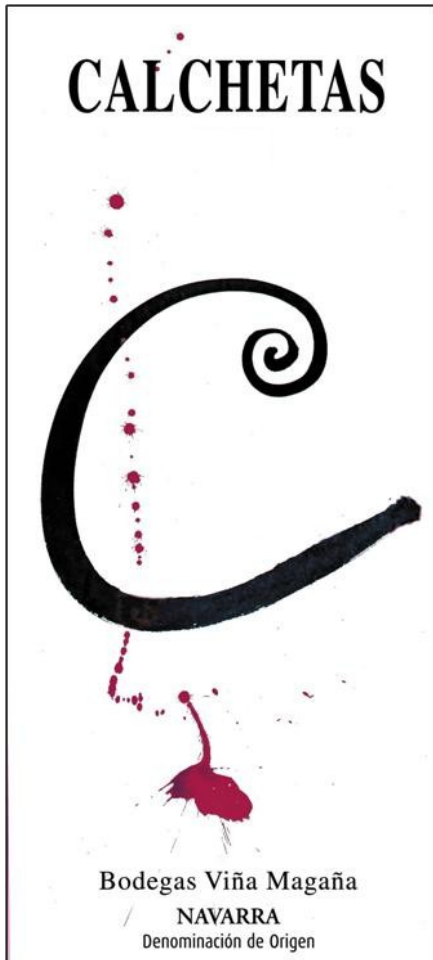
RED WINE FROM SPAIN
