This lush, rich, dark-fruited red pairs extremely well with braised lamb shanks. It is produced from vines planted in 1987, growing in calcareous clay soil in the Terra Alta wine region (Zone 5) at 356m (1,168') elevation. 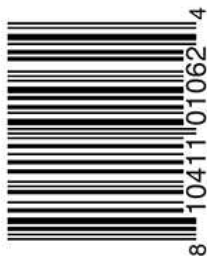
