The vines are tended in limestone and chalk soil. Average **temperature** during the growing season from April to October is 18.8°C (66°F) and annual **rainfall** is 330mm (13 in). **Oak-aged** for 3 months in French oak barrels. Vinos Sin Ley **pairs** extremely well with lamb.
