This southern Portuguese red drinks smoothly and roundly and will please the Cab and Malbec drinker. It pairs very well with snacks, pasta, meats, cheese and pizza. It is produced from vines planted in 1990, growing in the Alentejano wine region in sandy and loam soil at 250m (820') elevation. Average temperature during the April-Oct. growing season is 30°C (86°F), annual rainfall: 480mm (18.9"). It is aged 6 months in French oak barrels.

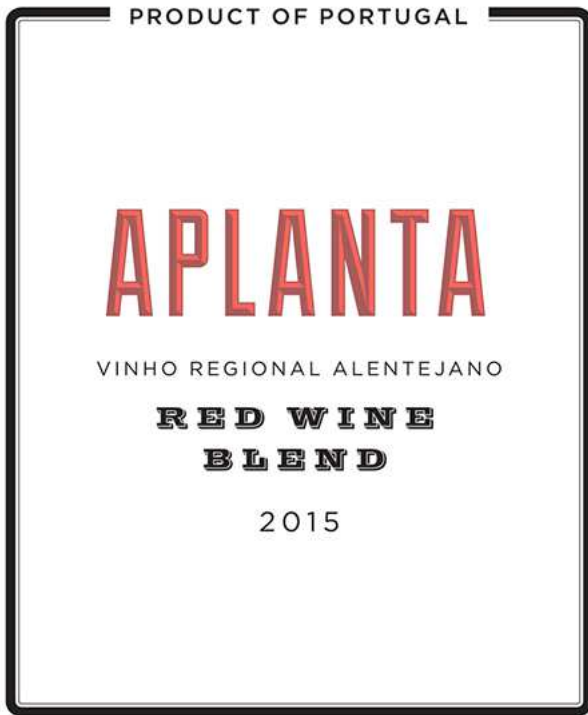
