ZEPA areas (Special Protection Areas for Wild Birds) are natural areas in which the ecosystem of migratory birds is protected for them to feed, reproduce and travel across. In these areas attempts are made to avoid the use of agrochemicals, the passage of overhead power lines and the excessive mechanization of farming work that might interfere with the breeding cycles of birds. Likewise, they foster the conservation of watering points and the use of crops which prevent the overexploitation of the soil and coexist in perfect harmony in the conditions described.

Yaca SPA is situated at an average altitude of 780 m (approximately 2560 feet) and contains our Monastrell de Campo Antico vineyards with vines planted over 70 years ago. Due to their age and the characteristics and orientation of the soil, the productivity of these vines is very low, resulting in a very high concentration of colour, flavour and aromas in their fruit.

This unique wine is the astonishing result of the combination of its prodigious nature and the human willingness to conserve and protect it.
