MAÇANITA DOURO 100% Sousão DOC irmãos e enólogos		
<p>Casta tintureira (i.e. com cor na polpa) do Norte do país - "conta-se que veio das margens do rio Lima" - já escreve Girão em 1822. Diz o mesmo ainda que tem tanta cor que pode-se com as cascas "fazer huma tinta excelente para cobrir os vinhos faltos de cor", como se descrevendo o atual papel do Sousão no Douro. Mais a norte, a mesma casta com o nome viril de Vinhão, bebe-se crua, extreme, tosca e orgulhosa como um bastião dos últimos sinais da ruralidade. Será este um Sousão ou será um Vinhão?</p> <p>Cépage teinturier (variété de raisin dont la pulpe est colorée) du Nord du pays - "on raconte qu'il vient des bords du fleuve Lima" - écrivait déjà Girão en 1822. Il affirmait également qu'il a tellement de couleur que "l'on pourrait avec les peaux faire une excellente teinture qui compenserait les vins souffrant d'un manque de couleur". Cela décrit en réalité le rôle actuellement donné au Sousão dans le Douro. Plus au Nord, le même cépage au nom viril de "Vinhão", se boit cru, extrême, rustique et fier, comme un gardien des derniers signes de la ruralité.
