The count of Silves fell in love with the sea and the vineyards of the Algarve. At the end of the 19th-century he planted his first vines at Morgado do Quintão. Today, almost 200 years later, we celebrate his legacy and the "real Algarve" in this algarvian white, made from the most notable local grape variety: Crato Branco.
