growing in the Valle del Ulla subzone within the Rias Baixas (Zone 1) wine region in sandy soil at 225m (738') elevation. Average temperature during the April–October growing season is 14.4°C (58°F); annual rainfall: 1,082mm (42.6"). Aged on the lees in stainless steel tanks for 3–5 months.
