Porto Santo Island emerged from the Atlantic Ocean 14 centuries ago, making it one of the oldest islands in the Portuguese archipelagos. It holds historical significance as the first island discovered by Portuguese sailors under Zarco's leadership in 1418. According to legend, it was here that the most luscious grapes were harvested, creating wines that brought fame to these islands. Today, less than 14 hectares remain cultivated by a resilient group of individuals. The people of Porto Santo are affectionately known as the "Profetas" on the neighboring island, a fitting nickname given the sight of old vineyards planted by the sea, close to the ground, sheltered from the ocean and wind by crochet walls or ingenious cane structures. Caracol wine originates from these vineyards, representing our first exploration of this unique terroir. Nuno Faria, a proud Madeiran restaurateur, and António Maçanita, an explorer of extreme terroirs and winemaker, have united after more than 15 years of friendship. Together, they celebrate and uncover the potential of these enchanted islands, giving rise to the creation of this wine.

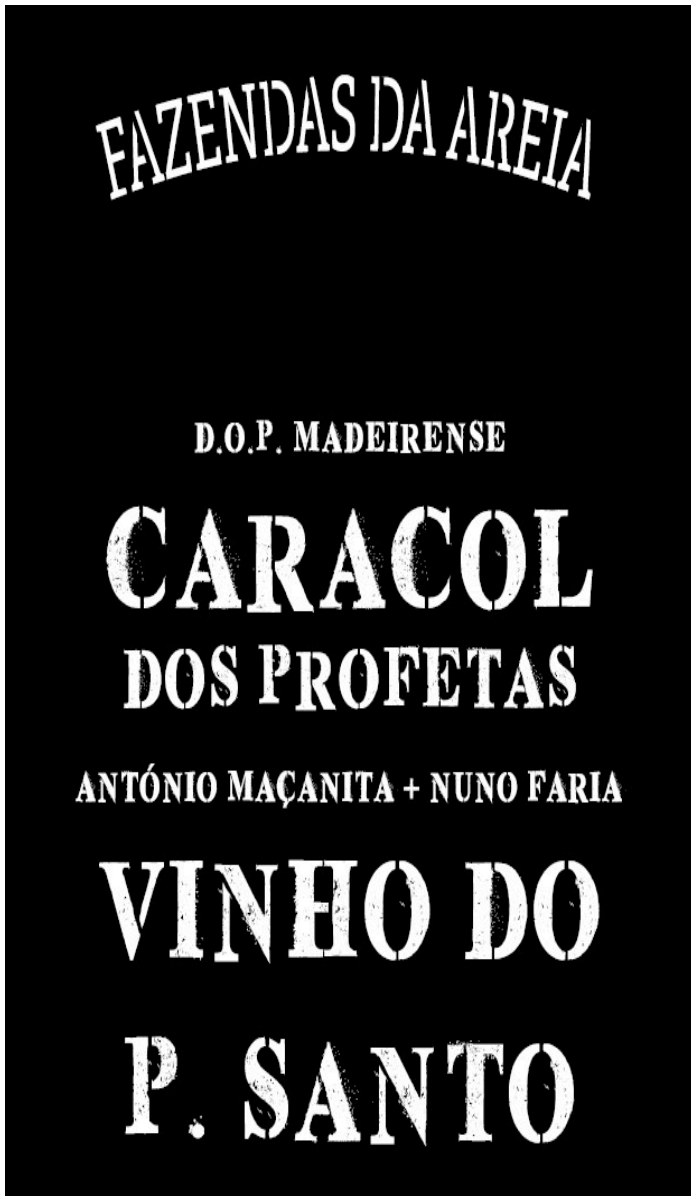
