This Tinta Negra dos Villões - Vale de São Vicente comes from small plots of old vineyards in the São Vicente Valley, where the small and tight bunches allow to untap on the unexplored potential in red winemaking of this grape variety. The grape Tinta Negra is part of the ancient grapes of Madeira, being still today the base of its famous fortified wines. Rare, it can only be found in small quantities in two other regions, also close to the ocean where it is known as Molor or Sobornho. Not be confused with the variety Negra Mole: it seems that its role in the past was to tint white wine in order to give it a golden hue very much in fashion at the time. As a red grape, it has always been seen as an inferior grape for red wine. Is it so? That's what we want to find out. Behind this wine, Nuno Faria, Madeiran and restaurateur, and António Maçanita, winemaker and explorer of extreme terroirs, friends for more than 15 years and have joined forces to celebrate and explore the potential of these enchanted islands.
