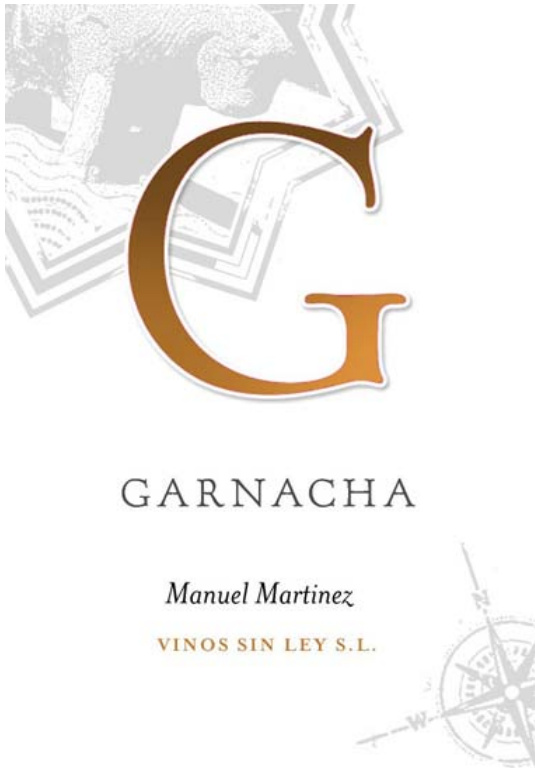

**GRAPES** 100% Garnacha



**THE WINE** Garnacha (aka Grenache), a grape of Spanish origin, is a variety requiring a long, warm, growing season to fully ripen. Made from 120 year old vines, hence the very low yields, concentrating flavor, intensity and aromas to the fruit. Located in Zone 7 San Martin de Valdeiglesias, Northwest of Madrid at 870m (2,850 ft). Tended in granite soil.



**CLIMATE** The high altitude of this southern Continental climate ensures very cool nights with hot days resulting in wines that possess great aromatic intensity. Average temperatures from Apr-Oct of 17.9°C (64.2°F) and yearly rainfall of 561mm (22").
